## SUBSCRIPTION RATES

(effective October 1, 2011)

The current rates of subscription are:

- I. For Attorneys-at-Law in Private Practice of 20 years standing and over \$9,000 per year;
- II. For Attorneys-at-Law in Private Practice of 10 years standing but less than 20 years standing - \$7,500 per year;
- III. For Attorneys-at-Law in Private Practice of 5 years standing but less than 10 years standing - \$4,500 per year;
- IV. For Attorneys-at-Law in Private Practice of less than 5 years standing \$3,000 per year;
- V. For Attorneys-at-Law in full time Legal Practice of Government and not permitted Private Practice:
  - a. Of 20 years standing and over \$9,000 per year;
  - b. 10 years standing but less than 20 years standing **\$7,500 per year**;
  - c. Over 5 years standing but less than 10 years standing \$4,500 per year;
  - d. Of 0-5 years **\$3,000 per year**
- VI. For Attorneys-at-Law overseas and not practicing in Jamaica US\$100
- VII. For Attorneys-at-Law not in active practice in any manner \$1,000
- VIII. The above subscription rates are subject to change and G.C.T.
- The subscription rates include a contribution of \$1 to the Association's Benevolent Fund.
